It is for information that in compliance to Notification No.
18/104/2001/44-2(6)/11420 dated 06.09.2024, PSVC-Draft Electoral Rolls-
2024 have been prepared under Rule 4 of Punjab State Veterinary Council Rules,
1997, containing the names of 2477 person whose name are entered/continued
up to 30-09-2024 in the Punjab State Veterinary Register. A copy of the said Draft
Electoral Rolls is sent herewith.

The Draft Electoral Rolls are to be displayed for inspection by
all concerned and for lodging claim and objections, if any, within 15 days
from the date of publication of the draft of rolls.

It is also for information that every claim for inclusion of a name
in the rolls and every objection to an entry therein shall be lodged in Form I
and II respectively, to the Registrar, Punjab State Veterinary Council. Ten
copies of each Form I and II are also sent herewith.

Form of claim and objection and the manner of their disposal

Every claim in Form I shall be signed by the person who requires his name
to be included in the rolls.

Every objection in Form II to the inclusion of a name in the rolls shall be
referred by a person whose name is already included in the rolls, shall be
countersigned by another person whose name is also included in the rolls.

Every such claim or objection, as the same may be, shall be examined by the Registrar who shall record his remarks thereon following which he may either allow or reject the claim or objection.

The decision of the Registrar allowing or rejecting a claim or objection shall be final.

You are, therefore, requested to kindly:-


1) display the above said Draft Electoral Rolls in your office on 04-01-2025 for inspection by all the concerned in the State/Institution/District and to lodge claim and objections, if any, in Form I and Form II as the case may be, personally by the person/s making claim and/or objection, to the Registrar, Punjab State Veterinary Council, Room No. 306, 3rd Floor, Livestock Complex, Sector-68, Sahibzada Ajit Singh Nagar on or before 19th January, 2025 (upto 05.00 pm).

The PSVC- Draft Electoral Rolls-2024, Form I and II are also available on online portal of the Council i.e. punjabstateveterinarycouncil.com for the purpose.

2) bring the above to the notice of all concerned in the State/Institution/District so that claim and objection/s, if any, could be lodged as stated above.

3) make available Form I and II to the desiring persons.


